8.1 Heritage Centre - Cllr's B Brothwell and C Bentley agreed to attend on Sunday 1st April 2012 and Cllr's L Newton and S Mayes provisionally agreed to attend on Sunday 6th May 2012.

8.2 Cllr C Hardstaff proposed that as part of the Queens Diamond Jubilee celebrations that a "village/residents photograph" should be organised. This was agreed in principle.

8.4 To reduce vegetation growth in the Docks it was agreed to introduce a series of "steps", by using railway sleepers, to restrict the water flow and therefore increase the water level. Prior to this being carried out it was agreed that the Docks should be cleared of vegetation.
